Age Concern North Shore is committed to encouraging businesses/organisations to strive to provide respectful, positive and easy to navigate experiences and services to older people. As part of this, we are inviting older people from the North Shore community to nominate a business for a **2017 Age-friendly Business Award**.

To be nominated for an award, the business may demonstrate some of the following:

- Be accessible for people of different physical abilities eg walker access
- Be respectful of your needs eg provides extra help if required
- Avoids a patronising manner
- Has clear communication eg easy to read signage and written material

Criteria for Nomination:

- a. Nominations can only be submitted by those aged 65 years or older and who reside on Auckland's North Shore
- b. Please do not nominate any business/organisation if you are related to or associated with any of its staff
- c. Only one business/organisation nomination per nomination form
- d. Offering a discount (e.g. to SuperGold Card holders), or running a business catering to older people would **not**, on its own, be considered sufficient evidence for a nomination
- e. All judging decisions will be final and correspondence will not be entered into
- f. All nomination forms will be kept strictly confidential and will remain the property of Age Concern North Shore
- g. Age Concern North Shore employees, Board members and their families are excluded from submitting a nomination

Age Concern North Shore and any business/organisation that receives an award, reserves the right to use information from a nomination form for promotional purposes (e.g. newsletter; website; Facebook etc). Media will be invited to attend the presentation of awards.
